Motion to approve audit request 2017-120 was made by Senator Roth, seconded by Assemblymember Obernolte, and failed passage 7-6 (Assembly 3-3, Senate 4-3).

**2017-124** San Diego County Department of Health and Human Services—Public Health Nursing Staffing Levels.

#### Assemblymember Hueso
