The following members were present at the August 8, 2018, committee hearing in State Capitol Room 447; Assemblymembers: Chair Muratsuchi, Acosta, Baker, Nazarian, Obernolte, Rubio, and Wood. Senators: Vice Chair Roth, Allen, Beall, Cannella, Fuller, and Lara.

The hearing commenced at 9:07 a.m. A quorum was established at 9:39 a.m. (Chair Muratsuchi, Acosta, Baker, Obernolte, Rubio, and Wood. Senators: Vice Chair Roth, Allen, Cannella, and Fuller).

Regular Order of Business

Of the 14 action items on the agenda, 6 were approved on the Consent Calendar. The remaining 8 were presented, of which 5 were approved, 2 failed, and 1 was retained for future consideration.

Consent Calendar

Waiver of Committee Rules 13 & 15

The waiver of committee rules 13 and 15 allows the consent calendar to be voted on and the State Auditor's analyses to be publicly released without committee discussion.

Motion to waive rules 13 & 15 was made by Assemblymember Rubio and seconded by Assemblymember Wood, and passed 10-0 (Assembly 6-0, Senate 4-0)

2018-120: San Francisco Bay Conservation and Development Commission **Assemblymember Mullin**

Request to audit the enforcement activities, funding, operational needs, and structure of the San Francisco Bay Conservation and Development Commission.
